PROPERTY: Approximately 172 acres generally located at the southeast corner of N.W. 87th

Avenue and N.W. 90th Street

PLAT/FOLIOS: A portion of the West 1/2 of Section 10, Township 53 South, Range 40 East, and a

portion of the Southeast 1/4 and the Northeast 1/4 of Section 10, lying in Medley, Miami-Dade County, Florida and identified as Folio No. 22-3010-000-0020 and

consisting of approximately 161 acres; and

A portion of the Southwest 1/4 of Section 10, Township 53 South, Range 40 East, lying in Medley, Miami-Dade County, Florida and identified as Folio No. 22-3010-
