RELEASE OF LIABILITY
AND
INDEMNIFICATION AND HOLD HARMLESS AGREEMENT

_____ (**insert name of User**), during the course of the temporary use of the “Town of Medley Resident Gym” property owned by the Town of Medley, Florida, a Florida municipal corporation (the “Town”), located at 7777 NW 72nd Avenue, Medley, Florida (the “Property”), hereby covenant and agree to defend, indemnify and hold harmless the Town and its officers, agents, servants and employees, to the fullest extent allowed by law, from any and all liability, claims, demands or losses of any kind whatsoever sustained by the Town or asserted against the Town by any person or entity, including for any property damage or bodily injury, wherein said liability, claim, demand or loss in any way arises out of or is related to the use, acts, omissions or negligence during use of the Property. User hereby assumes any and all risk of damage to the Property and injury to persons, including all employees, guests and invitees, while on the Property. User further agrees to conduct in such a manner so as to minimize disruption of the Property and all operations or business conducted thereon, agrees to abide by all laws, rules and regulations applicable to the Property, and agrees to repair any damage to the Property caused by reason of the use of the Property and restore the Property to the same condition as existed prior to our use.

User expressly acknowledges and agrees to release and waive any liability on the part of the Town and that the Town shall not be liable or responsible for any loss, damage or injury of any kind or character to any person or property, including any personal property or goods of the User brought onto the Property (i) caused by any defect in any building, structure, or other improvements on the Property or in any equipment or other facility located thereon; (ii) caused by or arising from any act or omission of the Town, or of any of its agents, employees, guests or invitees; (iii) arising from any accident on the Property or any fire or other casualty thereon; or (iv) arising from any other cause.

Gym Staff

All staff members are trained in CPR & First Aid. In addition, all staff members are required to clear a Level 2 background screening, or as required by State when hired by the Town of Medley.

Registration Procedures

The Town of Medley Gym is available to Medley residents 16 years of age and older. Minors (under 18 years of age) must have their registration filled out and signed by a parent/guardian. Each registered resident is allowed one (1) guest, resident must be present in order for guest to use facility.

In order to process a registration for the Medley Resident Gym the following must be completed and submitted:

- Gym Registration Form
- Release and Waiver of Liability Agreement
- Copy of a photo ID

Gym Rules & Regulations

It is our goal to provide a safe environment to all guests. To ensure a safe, pleasurable environment is maintained, all guests are expected to follow the following rules:

- All gym guests must sign in when entering the facility
- Appropriate attire/shoes are required at all times. For safety purposes, open toed, backless, skate shoes, crocs and flip flops are not permitted.
- No food, alcohol, glass containers, animals are permitted.
- No smoking
- Return weights to rack after use, do not drop weights
- Sanitize equipment after use
- The use of vulgar, harsh, aggressive or discriminatory language, gestures or actions are not acceptable under any circumstance.
- Careless or abusive use of items that belong to the Town or other persons that could result in the damage to such properties will not be tolerated.
