- Discussion and Action on the Request by Councilwoman Lizelh Rodriguez for Charitable Donation to SOZO Church in Connection with their Back-to-School Drive Initiative.
- Discussion on the Proposed Budget for the Fiscal Year October 1, 2025 through September 30, 2026.
