NOTICE IS HEREBY GIVEN that a SPECIAL MEETING of the Town Council of the Town of Medley, Florida, has been scheduled for Monday, November 30, 2019 at 5:15 p.m. at the Medley Municipal Services Facility located at 7777 NW 72nd Avenue, Medley, Miami-Dade County, Florida, 33166.The purpose of this meeting is to discuss the following:

- 1. Resolution of the Town Council of the Town of Medley, Florida; Providing Findings; Designating a Brownfield Area Within the Town for Real Property Located At 7400 NW 79th Avenue, Medley, Florida, as Depicted On Exhibit "A" and Legally Described on Exhibit "B", for the Purposes of Environmental Rehabilitation, Job Creation, And Economic Development; Authorizing the Town Mayor to Implement this Resolution; Providing for Severability; and Providing for an Effective Date.
- 2. An Ordinance of the Town Of Medley, Florida, Amending Chapter 62 "Zoning" by Amending Article III "District Regulations", Section 62-88(A), to Amend Regulations for Permitted Uses Within The M-1 Zoning District to Allow Last-Mile Logistics and Retail Distribution as a Permitted Use; Providing for Conflicts; Providing for Severability and Providing for an Effective Date.
