The purpose of the meeting is to discuss the following:

- Discussion on the Proposed Budget for the Fiscal Year October 1, 2023 through September 30, 2024.
- Discussion on the Proposed Tentative Millage Rate Based Upon the Certification of Taxable Value of Real and Personal Property Within the Town of Medley for the Fiscal Year October 1, 2023 through September 30, 2024.
